

Privacy Statement Includes

This privacy statement includes the following points, among others:

- Clear mention of the purposes for which Telesto processes personal data, as stated in this privacy statement;
- Collection of personal data limited to the data necessary for the purposes for which they are processed;
- Explicit consent is requested from you by Telesto when your consent is required to process your personal data;
- No disclosure of your data to third parties by Telesto, unless it is necessary to provide the requested service or
- Implementation of appropriate security measures by Telesto to protect your personal data, and Telesto also requires the same from parties processing personal data on behalf of Telesto;
- Respect for your rights, such as the right to access, correct, or delete your personal data upon your request.

This privacy and cookie statement explains the personal data we collect and use, the purposes for which we collect and use it, and the use of cookies. We recommend that you read this statement carefully.

Use of Personal Data

When you visit our website, create an account, request a brochure, fill out the contact page, or use other features of our website, you provide us with certain personal data.

You may also have provided us with data over the phone. We only collect, store, and use the personal data that you provide directly or that is clearly provided to us for processing.

We use the following data:

We use this data for the following purposes:

- Offering our services and products;
- Storage for the execution of the Agreement and publication in the Whois database;
- Informing about disruptions and maintenance of our services;
- Providing access to the Customer Portal, where you can access your administration;
- Granting access to your account;
- Processing your order and providing information about its progress;
- Contacting you when requested;
- Contacting you by phone;
- Gaining insight into the use of our website;
- Improving and evaluating our website and services;

Security of Personal Data

We take appropriate technical and organizational security measures to limit misuse and unauthorized access to your personal data. We use strict security procedures and access control.

Telesto also uses secure connections (Secure Sockets Layer or SSL) to protect all information transmitted between you and the website.

Minors

Telesto does not intend to collect data from individuals under the age of 18 and does not provide services to minors. If you come across personal data of a minor despite this, please contact us, and we will remove that information.

Data Retention

We do not retain the provided data longer than necessary to achieve the purposes mentioned in this privacy and cookie statement. We adhere to the legal retention period of 7 years, depending on the data and documents. We apply this retention period only to data that must be kept for that long according to tax legislation. We retain other data for an additional 1 year after the termination of the agreement (for example, after you have canceled or decided not to renew your Telesto service).

Confidentiality & Disclosure to Third Parties

We handle your personal data confidentially. We do not provide the personal data collected through our website to third parties for direct marketing purposes.

Furthermore, we will not disclose the information you provide to other parties unless it is necessary for the execution of the agreement or if we are legally permitted or required to do so.
